- (b) A lottery, if necessary, will be held the last week in February 2014.
- (c) Parents/guardians will be informed of acceptance or non-acceptance **prior to March Break and no later than Thursday, 6 March 2014.**
- (d) Parents/guardians must inform the requested school of their acceptance of the offer by **Tuesday**, **8** April **2014**.
- (e) No student will be admitted into an elementary school through Optional Attendance after Friday, 2 May 2014.

Note: It is the parent/guardian's responsibility to deliver this application to the school or schools of choice.
